

## **IRPC Annual Meeting Notes – May 1, 2025**

Meeting called to order at 8:00 p.m. by President Kermit VR.

**Annual Meeting Notes (May 2024)** – Annual meeting notes from last year were read by President Kermit VR. Meeting Notes were approved as read, 1st - Don E., 2nd Frank D., MC.

**Treasurer Report** – Detailed report provided by Treasurer Mike Palucci. Motion to approve Treasurer's report – 1<sup>st</sup> Don E., 2<sup>nd</sup> Frank D., MC

**By-Laws** – No change in current By Laws.

### **Annual Membership Dues Increase (3 Plans Suggested)**

**Plan 1** – Leave the same until review in 2026 for 2027 dues

**Plan 2** – Raise dues to \$60, review again in 2026 for 2027 dues

**Plan 3** – Raise dues to \$75 with ability to work 2 workdays and get \$103 off each signed off workday

Discussion took place regarding all three plans, pros and cons of each and some additional questions arose regarding intent to raise other club fees. President Kermit VR redirected the conversation back to the membership dues and suggested questions regarding other fees be brought up at a regular monthly meeting.

Motion made by member 1<sup>st</sup> Frank D. to raise dues to \$60 and re-evaluate again for 2027 and include other club fees, 2<sup>nd</sup> Andy. Further discussion took place and Frank made a motion to amend his first motion as follows: Raise dues \$5 a year for 3 years with annual review and option to adjust as needed – 1<sup>st</sup> Don E., 2<sup>nd</sup> Andy, MC – First \$5 raise in dues begins October 1, 2025 for 2026 annual membership dues.

**Lifetime Membership Dues** - Lifetime dues will increase as the annual dues increase. Several options regarding increase and age limitations for lifetime memberships. The following suggestions were made and will be reviewed and voted on next month.:

Ages Under 40 years	\$600
Ages 40 – 49 years	\$550
Ages 50 – 64 years	\$500
Ages 65 and greater	\$250

### **Membership Dues Increase (continued)**

Please note, these are currently suggestions under consideration and the normal lifetime membership dues is equivalent to 10 annual memberships and the above fees will be adjusted accordingly once accepted. Motion to increase lifetime memberships and set age limitations as written above with review and further discussion and voting next month, 1<sup>st</sup> Andy, 2<sup>nd</sup> Angie M., MC.

**Annual Elections of Officers** – Treasurer Mike P. has decided to step down for 2025 and motion to nominate Angie M. as new treasurer, 1<sup>st</sup> Bob D., 2<sup>nd</sup> Don E., MC. Mike did a super job this last year after taking over for long time Treasurer Rick C. Angie M. will need to immediately get a NRA membership as required of all officers and as Treasurer, she must also get added to the club's checking accounts, replacing Mike P.
